## 2022-2023 PROGRAM DEADLINES

Program applications will be accepted beginning at **8:00AM** on **April 18<sup>th</sup>** through **June 27<sup>th</sup>, 2022**.

Applications can only be submitted online following the instructions provided here and on the VC website and are prioritized on a first-come, first-serve basis. Incomplete applications will not be reviewed. Typically, approximately 28 students are accepted in the Graphic Design degree track and 20 in Multimedia Arts, with a cap of 48 total new students each year. If openings remain after the deadline date, the application period may be extended. Check the VC website for announcements regarding changes.

Applications must be submitted using a shared folder using Google Drive. All Chemeketa students have access to this service through their college e-mail address. Retain a copy of this application for your records.

▶ For the **AAS in Graphic Design**, submit 9-12 examples of previous creative work. Fine art, 3D work, woodworking, photography—anything that demonstrates your creative thinking.

▶ For the **AAS in Multimedia Arts**, submit a mix of 5-10 items of your creative work in with fields of photography, filmmaking, digital video, animation, and motion graphics or other creative media.

## PROGRAM PREREQUISITES

Prerequisites are established to be sure that you are prepared to be successful in program level classes. Success in these prerequisite classes will prepare you for the rigors of the Visual Communications program.

**Visual Communications program applicants must either test out of the program pre-requisites by taking the college placement tests, or complete the classes with a 'C' or higher.**

Students may apply for the program while prerequisites are being taken, but acceptance is conditional on having completed all prerequisite courses with a grade of "C" or higher prior to August 12<sup>th</sup>, 2022. Note that your financial aid status is affected by completing these prerequisites, and not having them completed may require additional time in the program.

Regarding the math requirement, please note that scoring above XMTH5001A on the placement tests does not waive the program math requirement but allows the student to complete a higher level of math. Students intending to transfer to a four-year school must complete MTH105 or higher for a Bachelor's degree. Check the requirements of the college you are interested in attending. Scoring above the levels indicated on the placement tests allows the student to enroll directly in required program courses in writing, reading, and mathematics.

- I understand that an offer of admissions to the Visual Communications Program is dependent on my having completed, with a minimum grade of "C," any required prerequisite courses indicated on my college placement tests or be currently enrolled in these classes.

- I understand that if my application demonstrates some program readiness, but that additional work is required before enrolling in the program, I will be placed on a deferred list and may resubmit my application when indicated work is completed. I will be notified of my application status by email. I may make an appointment with the program chair to clarify my admission status.
- I understand that if my application packet does not demonstrate program readiness, I will be notified by the myChemeketa email address listed above. I may make an appointment with the Program Chair to clarify my status.
- I agree to follow an approved term-by-term plan to assure that I will graduate in the designated length of time.
- I have read and signed the student work/media release as part of this application.
- I will work with my VC advisor to help me select and follow a term-by-term plan for my coursework in the VC program.
- I understand that I must maintain a grade of "C" or above in all program classes. Failing to meet these requirements, I will be removed from the program until I retake and pass the class that did not meet the requirement. Since most program classes are only offered once a year, this may result in an additional year to complete the program. I will meet with my assigned faculty advisor immediately upon receiving a grade lower than a "C" to develop an alternative academic plan. In addition, I must maintain an overall grade point average of 2.0 in all required classes. Any exception to this policy will be determined after a joint meeting with all VC program faculty.
